SILVERADO CANYON, CA – Fire, rain, now mud – the forces of nature have disrupted the idyllic life in the canyons, specifically for residents residing in the "Bond Fire scar area."

Supervisor Wagner brought forward Item S33D to the Board of Supervisors,

authorizing the County to [act as a local sponsor](#) for federal funding to remove debris and obstructions in Silverado and Anderson Creeks upstream of Kitterman Bridge, and to clear rainstorm debris in Silverado and Wildcat Creeks upstream of Silverado Canyon Road culvert. The Board approved the item at the January 11 meeting.

Supervisor Wagner thanks OC Public Works for ensuring our County lands and roads are safe and appreciates the efforts made by our canyon residents to clear away the wreckage. His office remains dedicated to serving its constituents and improving public safety wherever possible.
